Term of Agreement. In general, Middle East commercial agency agreements should be made for a short definite term, preferably no longer than two years, and not automatically renewable. Under some dealer protection laws (such as in Jordan), a commercial agent may face greater difficulty claiming non-renewal (rather than termination) compensation. A short definite-term agreement might also lessen the commercial agent's reasonable expectation of future profits.

UAE Legislation on Agency Law. In the UAE, commercial agencies are governed by the Federal Law Number 18 of 1981 concerning "Organizing Trade Agencies" (as amended by Federal Law Number 14 of 1988, Federal Law Number 13 of 2006, and Federal Law Number 2 of 2010). This law is often simply referred to as the UAE Agency Law.

Relationships that are commonly associated with agency law include employer-employee, administrator-decedent or executor, and guardian-ward. Agreements that result in the formation of agency-type relationships can be implied or express, and both the principal and the agent can be an entity (such as partnership or corporation) or individual.

General Legal Provisions Applicable to Agency Agreements As noted, commercial agency is mostly regulated at the state level in the US State laws on agency mainly address commissioned agency, and, where in force, is primarily aimed at ensuring that the principal timely pays the agent the commissions that are owed by imposing liability on the principal for a multiple (often two to four times) of unpaid commissions, as well as for reimbursement of the agent's attorneys' fees and costs ...

Legal Basis. The legal status of commercial agents in the European Union is regulated in the Council Directive 86/653/EEC of December 18 th 1986 on the coordination of the laws of the Member States relating to self-employed commercial agents. It is a minimum directive, which sets the lower limits for protecting commercial agents in the EU.

## **Commercial Agents in the EU - EU-Distributors**

Parties Obligations: while the Agency Agreement is governed through the Agency Agreements Law (which includes mandatory rules), Distribution Agreements are subject to the Civil Code and therefore the "freedom principle" applies in order to set forth the parties obligations regime. The Distributor is not paid by the Principal.

Agency agreement An agent is a legal or physical person vested with the power to negotiate and/or conclude contracts on behalf of another person (the principal), either in the agent's own name or in the name of the principal, for the: (i) purchase of goods or services by the principal, or (ii) sale of goods or services supplied by the principal.

**Agency agreement - Concurrences**

Dutch law has a specific legal regime for agency agreements, this is contained in Book 7 of the Dutch Civil Code. While Dutch law adheres to the principal of contractual freedom, a large part of commercial agency law is mandatory. The parties (the agent and the principal) are not permitted to deviate from mandatory provisions.
