[2] The Courts of India have recognized custom as law only if the custom is (1) "ancient or immemorial" in origin, (2) "reasonable in nature and continuous in use," and (3) "certain.". [3] The Courts have interpreted " ancient or immemorial" to mean that for a custom to be binding it "must derive its force from the fact that by long usage it has obtained ...
