General APA Guidelines Your essay should be typed and double-spaced on standard-sized paper (8.5" x 11"), with 1" margins on all sides. Include a page header (also known as the " running head ") at the top of every page. For a professional paper, this includes your paper title and the page number.

In-text citation is usually written in a parenthesis with the last name of the author and year separated by a comma. If the last name of the author is included in the text, write only the year inside the parenthesis. Include the name of the author, year, and page number if a part of a work is directly quoted.

Helpful Tips: Treat a government document as a book, report, or brochure. If a person is named on the title page, use her or him as author. If no person is named, use the government agency, department, or branch as a group author. Give the name of the group author exactly as it appears on the title ...
