The full judicial power in Singapore is vested in the Supreme Court as well as subordinate courts by the Constitution of Singapore. The Supreme Court consists of the Court of Appeal and the High Court. The Court of Appeal exercises appellate criminal and civil jurisdiction, while the High Court exercises both original and appellate criminal and civil jurisdiction.

Singapore developed an independent judicial system but the Judicial Committee of Her Britannic Majesty's Privy Council remained as Singapore's final court of appeal.
