Facilities Management Policy and Procedures

(A) A residential facility shall develop a written admissions policy specifying the type of child who will be accepted into the facility and the conditions under which a child would not be accepted. SAMHSA has provided guidance that patients seeking treatment, or in treatment, in a residential treatment facility should be evaluated for referral to a Level 1 or 2 program (outpatient, intensive outpatient programs (IOP) and partial hospital programs (PHP)). Utilization of telehealth visits are strongly recommended.

Residential facilities are for youth who are required by a judge to stay in the care of the Department of Juvenile Justice for an extended time. There are facilities located throughout Florida. A youth's placement depends on the commitment plan, not on the location of the arrest.
