Scots property law governs the rules relating to property found in the legal jurisdiction of Scotland. As a hybrid legal system with both common law and civil law heritage, Scots property law is similar, but not identical, to property law in South Africa and the American state of Louisiana.

In addition, the Land Registration (Scotland) Act 1979 (as amended by the Title Conditions (Scotland) Act 2003) provides that, as of 1 April 2003, first registration will be required on any transfer of an interest in udal tenure that had not previously been entered in the Land Register, as real rights can only be obtained by registration.

Towards the end of its first parliamentary term, the Scottish Parliament passed the Land Reform (Scotland) Act 2003. This statute sought to broaden access to land in Scotland in two ways: in the sense of liberalising the law relating to outdoor access; and in the sense of giving some communities the right to acquire land in certain circumstances.

Under section 8 (3A) (d) of the Land Tenure Reform (Scotland) Act 1974, the Scottish Ministers can, by Scottish Statutory Instrument (SSI), exempt certain types of lessees from the operation of the 20 year lease rule. (The "lessee" is the person to whom the lease is granted - the tenant or lease holder).
