Title VII defines sex discrimination in employment as including failure or refusal to hire, discrimination in discharge, classification of employees or applicants so as to deprive individuals of employment opportunities, discrimination in apprenticeship and on-the-job training programs, retaliation for opposition to an unlawful employment practice, and sexually stereotyped advertisements ...

The phrase is contained in Title VII of the Civil Rights Act of 1964, which does not mention sexual harassment but outlaws discrimination in the workplace on the basis of race, sex and religion.
