How Income and Distributions are Taxed. In the first category, the LLC defaults to pass-through tax status. In a single member LLC owned by an individual, by default, the LLC's income and expenses are not reported on a separate tax return. The single member LLC is disregarded for tax purposes.

Avoid signing a document as the "owner" of an LLC. This exposes you to personal liability, since owner is usually not an official title. The title "member" or "managing member" often suffices for owners of single-member LLCs, or for LLCs that allow all members to sign contracts.
